### Frequently Asked Questions

#### Context

The Aboriginal Languages Trust (**ALT**) administers grant programs, referred collectively as the Aboriginal Languages Community Investment Program, to support the growth and nurturing of Aboriginal Languages in NSW, consistent with the *Aboriginal Languages Act 2017* (AL Act).

The Aboriginal Languages Community Investment Program has five funding streams, one of which is:

The **Aboriginal Languages Growth Program** is an open, competitive program offering grants from \$30,000 to \$90,000 to eligible applicants.

#### Aboriginal Languages Growth Program

The Aboriginal Languages Growth Program was established in December 2024, as part of the transition from the Partnership Funding Program and Sustainable Funding Program to a more targeted, effective and efficient Grant Program across the ALT. The Grant is administered and funded by the ALT. The Aboriginal Languages Growth Program was established to support eligible Aboriginal Community Organisations, groups and sole traders to undertake practical and meaningful Language projects which involve the deep transmission of Aboriginal Languages and have a broader Community impact, to grow and sustain Languages.

#### When can I apply?

**Applications open** at 9:00am on Monday, 27 January 2025.

**Applications close** at 11:59pm on Sunday, 9 March 2025.

#### What do I need to do before I apply?

You should read the Program Guidelines to make sure you are eligible for funding and can meet the specific information and evidence requirements.

## How do I apply?

All ALT grants are administered using the electronic Management System, SmartyGrants. You will need to create a secure account with log in name and password in the [SmartyGrants Portal](#). You can then complete your online application form via the [ALT SmartyGrants Home Page](#).

## Can I submit more than one application?

No, applicants are limited to one application per funding round.

## Can I get support to prepare my application?

## If I am ineligible, will I be told?

All applications will be screened for project eligibility. Ineligible applicants will be notified in writing.

## If I am successful, when and how will I receive funds?

The Aboriginal Language Growth Program funds will be paid directly to the applicants nominated bank

account, as identified in your Funding Agreement, within four (4) weeks of the Agreement being signed and returned to the ALT.

## I am part of a local Community language group. Can we apply?

Yes, an unincorporated organisation or group can apply by entering a valid and current agreement with an eligible organization to auspice the funding.

## If there is in-kind support or other funding contributions for my project, do I need to include that in my application?

Yes, if your project will receive in-kind support or other funding contributions to assist in its delivery then this should be included in the budget section of your application. This helps build a more accurate picture of what it will take to deliver your project and can help inform the design of, and funding allocated to, future rounds. It can also demonstrate community support and project buy-in.

## If I am successful, will the ALT pay GST on top of my grant funding amount?

In accordance with the NSW Grant Administration Guide Para 4.1.4, “a ‘grant’ is an arrangement for the provision of financial assistance by the NSW Government (or on behalf of the NSW Government) whereby money:

- is paid to a grantee other than the NSW Government
- is intended to help address one or more of the NSW Government’s policy outcomes
- is intended to assist the grantee to achieve its objectives
- *does not result in the return of goods or services by the grantee of an equivalent value to the NSW Government (i.e. it is a non-reciprocal exchange).*

As a result, ALT Grant payments are GST exclusive as there is no ‘Supply’ of goods and services to the ALT in return for the Grant payment. As such Grantees need to process the Grant payment in their financial systems as GST exclusive. If an invoice is incorrectly submitted as including GST the invoice will be rejected for rectification.

## What do I do if I need to change my something related to my approved project?

When unexpected events affect your project, it may be necessary to request a change to your grant agreement. If this occurs, the first step is to contact the ALT as soon as possible and request a Variation through the [grants@alt.nsw.gov.au](mailto:grants@alt.nsw.gov.au) email. If the proposed changes to your project are considered minor (e.g. extension of time request or slight change of scope) and does not substantively impact the approved purpose,

timing or conditions of the grant can be reviewed and approved by the Grants Administration Team.

You must notify ALT and request a Variation where:

- There is a change to any listed key personnel of the project team,
- There is a change in the approved expected outcomes,
- There is a change in project duration or cost,
- There is a change in your financial status – such as bankruptcy,
- You can no longer deliver the project, and/or
- Or for any other reason where you identify you may not be able to deliver on the funding agreement.
